
# facts & figures



The DOWNPASS Standard has been developed in 2016 and entered into forces as from January 1, 2017. The first audits were completed in spring 2017. The demand in the industry for audited down and feathers has increased significantly. The same applies to the retailers reflecting the growing demand among the end users.



Even though it is a quite new seal, the DOWNPASS is the most widespread zero tolerance standard in the bedding industry for the ethical sourcing of down and feathers and it has also a significant share in the fashion market. Its USP is the combination of animal welfare and quality issues.






